**Activities & Awards:** Please list activities, in order of importance – most recent and most important first. Provide year of activity or award if possible. You may attach one extra sheet if needed. Please don't write on the back of the application. For Princess contestants, list all activities where your daughter has interacted with other children or adults for example Pre-School, Sunday School, Dance Class, etc.
